Review of economic, community, downtown and workforce development for Tiffin and Seneca County, Ohio



Welcome

Last year, our organization celebrated its 40th anniversary since its creation in 1983 as the Seneca Industrial and Economic Development Corporation (SIEDC). At that time, local leaders in the public and private sectors recognized the need for a collaborative effort to achieve sustained economic success in Tiffin and Seneca County.

Today, the cooperation that began in 1983 is still going strong. The Tiffin area and surrounding rural areas of Seneca County have experienced significant growth in job creation and capital investment. In the previous year, a remarkable \$109 million was invested in various projects. This investment led to the creation of over 213 jobs. Our local economy is thriving, and the Tiffin-Seneca micropolitan area consistently ranks in the top 10% of all micropolitans, achieving multiple top ten finishes over the last decade in a hyper-competitive field of nearly 600 like-sized communities.

Although the years ahead will present their share of challenges, we must see them as opportunities to position ourselves for future growth and economic success. 






Economic Development

ALDRIDGE ELECTRIC

The spec building at Eagle Rock Industrial Park was sold almost immediately after completion to Stout Development, parent company of Alridge Electric. Over \$4 million has been invested, creating 20+ high-paying jobs. In addition, Stout Development has purchased two additional lots for future growth and development.

TPC FOOD SERVICE

After acquiring the former home of General Electric at the end of 2021, TPC Food Service moved after the completion of a major renovation. With more than \$6 million in capital investment and 30+ new jobs, the Maibergers have plans to expand the facility, including relocation of a specialty cheese blend processing line to Tiffin from Michigan.

HEAVENLY PIZZA

Long time Tiffin staple, Heavenly Pizza, began construction of their new 4,300 sq/ft full-service restaurant at 68 W. Market Street with plans to open in late Spring of 2024. Owner John Hill also announced the launch of the national franchise, Heavenly Pizza, with nearly a dozen new locations from Ohio to Georgia. Tiffin will serve as headquarters for the new brand.

WEBSTER INDUSTRIES

2023 proved to be another successful year for Webster Industries as the company invested \$6 million at their Tiffin plant to increase production capacity. With the closing of the foundry completed, all workers were retained and moved to production. Webster continues to be one of the industry leaders in Seneca County for employment and investment.









Community

TIFFIN COMMUNITY KITCHEN GROUNDBREAKING

After three years of intensive collaboration between Old Trinity Episcopal Church, Seneca County Common Ground, and with valuable assistance from TSEP, a groundbreaking ceremony marked the beginning of the Tiffin Community Kitchen in the fall of 2023. TSEP successfully submitted and managed a State



Capital Budget request, securing \$300,000 as a crucial component of the project's overall capital stack, which exceeded \$2 million. Situated directly in the heart of Downtown Tiffin, this transformative project is poised to function not only as a central gathering place for the community, but also as a hub for local foods and a resource for vocational training and entrepreneurial advancement.

BROWNFIELD EVALUATION AND REMEDIATION

TSEP, in conjunction with the City of Tiffin and the Seneca County Land Bank, has been working to evaluate the former Rainbow Muffler site and ensure its continued productive use. Funded by the state's Brownfield Remediation program, historical and site evaluations were completed. TSEP coordinated minor lot repairs to prevent adverse effects on surrounding businesses. At the end of 2023, this work resulted in a report to guide the final remediation of the site.



Rural

TAVERN 19

In the summer of 2023, Tavern 19 in Bloomville opened its doors. TSEP's press release on the grand opening became our most widely circulated release of the year, garnering several hundred thousand impressions. Additionally, Tavern 19 announced the expansion of its amenities, introducing a new kitchen facility and patio to further enrich the character and offerings available in Bloomville.



Entrepreneurship

FLOWERLAND

Flowerland, the longstanding floral shop situated outside of Fostoria, was successfully sold through the Tiffin-Seneca Entrepreneurial Opportunity Clearinghouse. This listing played a pivotal role in preserving a community institution with a devoted customer base.



Downtown Tiffin

Downtown Tiffin maintains its national and state accreditation from Main Street America and Heritage Ohio, following the implementation of the 4 Point The Main Street ApproachTM.

Workforce Development



OHIO MEANS JOBS

Almost 400 job orders were entered, with many for multiple openings. The OhioMeansJobs office partners with TSEP to assist employers with hiring and training employees.

APPRENTICESHIPS

One apprentice was awarded his Certificate of Completion of Apprenticeship by the Greater Ohio Workforce Board and four apprentices were enrolled.



MANUFACTURING SHOWCASE

The 8th annual showcase was held in October at Sentinel Career Center. Approximately 650 students from nine local schools met with 18 Seneca County employers to complete hands on activities that highlight skill sets that are important to manufacturers.

WORK ADVANCE

Manufacturers are reimbursed up to \$4,000 per employee.

Employers are reimbursed up to 50% of the cost to upskill current workforce.


